
"RICHMOND, HER PAST AND PRESENT, by W. Asbury Christian. Richmond: 1912, p. 22, "Under this charter the first city election was held at Henrico Courthouse Tuesday, July 2, 1782. Turner Southall and Gabriel Galt were appointed to supervise and count the ballots. The following citizens were elected: Isaac Younghusband, William Hay, James Hunter, Robert Mitchell, William Foushee, Richard Adams, James Buchanan, Samuel Scherer, Robert Boyd, Jacquelin Ambler, John Beckley, Robert Mitchell, and James Hunter Aldermen, which left as councilmen Younghusband, Adams, Buchanan, Scherer, Boyd, and McKeand."

p. 32-33, "But the greatest convention ever held in the State was that which met in Richmond June 2, 1788, to consider the question of ratifying the Constitution of the United States as prepared by the Convention of Philadelphia. All depended upon Virginia, for if she refused to ratify it, it would not stand. The convention was called to order in the State House. (Editorial note: The history of 1917 Selective Draft Act as far as Raleigh County and adjacent Southern W. Va. is concerned is tied in closely with the World War I history of both Jackson Smith—long-time famous Raleigh County clerk—and his equally prominent son, Aubrey O. Smith, outlined below as a permanent record of this important period in American history. See INDEX for further reference to these two gentlemen.)

On April 6, 1917, as a direct result of the many atrocities committed against American shipping and the use of the freedom of the seas, the Congress of the United States of America declared war against Germany. On April 25, 1917, Hon. John J. Cornwell, Governor of the State of West Virginia, appointed George S. Wallace, Major Judge Advocate General, ORC, of Huntington, as head of the newly formed Department of Military Census and Enrollment. It was definitely known then that the Act would become a law and preliminary preparations were immediately instituted so that on May 18, when the Selective Draft Act became a law, the state was in readiness for operation.

Under this law the Registration was decentralized under the direct supervision of Registration Boards established in each county consisting of the Sheriff, County Clerk and County Health Officer, and two citizen members, and the Mayor and five citizens in cities of 30,000 population


The Registration Board of Raleigh County was composed of W. L. Foster, Sheriff, Jackson Smith, County Clerk, Dr. D. W. Snuffer, County Health Officer, and Joe L. Smith and T. K. Scott, citizen members. Aubrey O. Smith, Chief Deputy in the office of the Sheriff, was delegated to administer the operation of registration. Registration places and registrars were secured throughout the county and as far as possible using the same places and registrars used in the last general election. Equipment and supplies were delivered at all appointed places so that all was in readiness by the evening of May 26 for registration on June 5.

On that date 4266 males were registered in Raleigh county, many registering later who were unable to attend at the appointed time. It should be noted here that all personal services rendered in this program were patriotically donated without cost to the Government, as did similarily 2423 persons out of 3630 in the state. In registration Kanawha county led the state followed in order by McDowell, Fayette, Harrison, Cabell, Marion, Mercer and Raleigh.

On June 26 the Registration Board completed its work and delivered to the newly appointed Federal Selective Draft Board all registration material acquired during its operation. The permanent board for Raleigh county was composed of T. K. Scott (R), Chairman, Joe L. Smith (D), Clerk, and Dr. K. M. Jarrell (D), Member. It is noted that many board members within the state served as clerk in the initial operation.

A second registration was held on June 5, 1918, for those reaching draft age since the first registration, and a third registration held on August 24, 1918, for those becoming 21 years of age since June 5. On August 31, 1918, President Woodrow Wilson, by proclamation, appointed September 12, 1918, as a day of registration for all male persons in the United States between the ages of 18 and 46 who had not previously registered or were otherwise exempt.

The Selective Draft Act was in operation from May 26, 1917 to May 1, 1919. At its termination the following citizens were attached to its various segments. Local Board: T. K. Scott, Chairman, Joe L. Smith and Dr. K. M. Jarrell, Members, and (Prof.) W. R. Howell, Clerk. (Continued on page 989)

He has 13 great-grandchildren.



But, she has not spent her retirement idly. After long and tedious study she has developed a highly effective teaching method which is likely to become of widespread or universal use. Seeing the critical need for a method of learning to "read by the word, picture, story or project", she devised "THE SHORT ROAD TO READING" a "HEAD-START EDITION" under her writing name, Willa P. Elkins, published and copyrighted (1965) by herself, and put her methods into book form.

Illustrated and enhanced pictures galore with easy association to the printed word, (by) her book lends itself to expansion to keep pace with the students' development. The first unit is being placed in Shady Spring Elementary School. Principal Guy Rumberg sanctioned the placing of the book in the school on a trial basis, with the idea that it may get enough general attention to merit some financial help on it.

Mrs. W. C. Meek, a parent of one of the children Mrs. Elkins has tutored, stated that "Mrs. Elkins taught her son two grades in one year." 
says. She added: "I have had but one child to go through my class without learning to read; I believe I could teach him now. That was during the early part of my teaching."


Mrs. Elkins stated that when she begins tutoring a non-reader, the first step is let him read her first story containing 36 words with phonetic sounds of every letter in the alphabet and picture words for each sound.

The first page of her book is made up of ten pictures of animals and objects containing all letters of the alphabet. Pages 20 and 21 of her composition consist of pictures showing the phonetic sound of each letter of the alphabet (picture with word). Pages 22-23 show each of the consonant blends. Then the next step features a picture with each of the 36 words in the first story, Only 6 verbs are used in the story.

After a non-reader has mastered this part of the text, a list of tongue twisters including the words that have several "like endings" are shown to motivate the child to further their learning.

The first unit contains 4 stories, the last one being "My Big Story" containing all the words learned to this point.

Mrs. Elkins has completed the first unit of her book and expects to complete the entire book in the near future.

According to Mrs. Elkins, she first got this idea, some years ago when she discovered her daughter had an eye problem and had fallen behind in her reading abilities. She first purchased reading cards and the set of books centered around a child's first 500 words. This method helped her daughter, Nancy, to such an extent that Mrs. Elkins first developed the idea of teaching retarded children and non-readers through association.


Mrs. Elkins has taught school for 36 years, including grades 1 through 12. During this span of years in the teaching field, she was principal of the Sullivan Elementary School for 2 years and principal of the Whitby Elementary School for 5 years. She has three degrees, an AB degree in Elementary Education in 1937 from Concord College and an AB in the high school field at W. Va. Tech in 1933, MA degree, 1940, at Peabody College.

Two full years of advancement in reading abilities are contained in her book, Mrs. Elkins stated.


In addition to the very comprehensive books mentioned above, she has invented a two-sided device with sliding letters which may be manipulated by her pupils in such a manner as to arrange the spelling of certain pictured illustrations corresponding with illustrations. This device a very ingenious mechanism must actually be seen and demonstrated to be appreciated.

All in all the book and the device, together with the very efficient arrangements of chosen words and sentences with vivid illustrations seems likely to become a most important system of modern computing age of machine teaching, not only retarded children but many others as well. Surely Mrs. Elkins' orderly process and learned discovery should receive the complete attention and study of all of our up-to-date school systems. Mrs. Elkins with her equally highly educated husband and son and daughter certainly represent with their vast knowledge of teaching the English language to our beginning citizens the very epitome of experience and ability. 


JOHN HOWARD McCULLOCH, JR. In a late column from the hand of Beckley's favorite historical writer, the Reverend Shirley Donnelly comes an interesting run down of the McCulloch family. He starts off with information collected from Edward McCulloch who lives at the ancestral homestead at Henderson, in Mason County where Ed McCulloch was born April 30, 1889. Ed is a brother of the late Dr. John H. McCulloch (see this page), but four years Ed's senior. Their parents were Charles E. McCulloch (1850-1905), and Emma C. McCulloch (1861-1958). Charles E. McCulloch is buried in the Andrew Bryan Graveyard on the McCulloch lands at Henderson but his wife is entombed in the McCulloch Mausoleum in Sunset Memorial Park. Mrs. Emma Mc-Culloch died at home at 1522 Harper Road on June 30, 1958 at the great age of 96 (she was Miss Emma Chapman before her marriage).

In the days of long ago Ed McCulloch's great-great grandfather and his wife and children left Pennsylvania. They were coming down the Ohio River on a boat when they were attacked by the Indians. Mrs. McCulloch was shot through the arm near Eight Mile Island in the Ohio. Because of this wound the family came ashore at Eight Mile Island in order that the wound might recover. Where they landed the McCulloch pioneer family liked it so well that they decided to settle there. The land where they settled and which they purchased was eight miles up the Ohio from Point Pleasant. They had three sons and three daughters.

Two of those boys ultimately went to Point Pleasant and started a store. However the third son remained on the farm bought by his father. He was John McCulloch, the great grandfather of Edward McCulloch. It ran in the McCulloch family to name men folks John.

Grandparents of Ed McCulloch and Mrs. A. U. Tieche were long lived people. On their grave stones these legends are listed; "John McCulloch, Died June 12, 1884, (Continued on page 970)

and Raleigh in 1944 and unsuccessfully ran for election in the fall of 1944, the district having a Democratic majority of 56,000 which the Republican nominee could not overcome though he reduced it to approximately 18,000. Judge Maxwell entered the Primary as a candidate for Judge of the Supreme Court of Appeals in 1948, in a contest in which there were two to be nominated and three candidates. Judge Lewis Miller of Jackson County and John Copenhaver of Charleston (Kanawha County). Judge Maxwell was nominated but ran an unsuccessful race in the fall election. Judge Maxwell entered the Primary campaign as candidate for Governor of the State of West Virginia in 1952, but was defeated by Rush D. Holt who had only recently abandoned the Democratic Party and became a Republican candidate for Congress. He, nevertheless was defeated in the fall election. (See INDEX)

Beckley followed in his exact footsteps and did the same performance, graduating in the Class of 1923.

An extract from the Register of Graduates, USMA, make the above experience at the great military institution especially interesting: General Alfred Beckley graduated 9th in a class of 35 in 1823. Colonel Stuart Alfred Beckley graduated 22nd in a class of 261 in 1923. Thus: Relative Standing Positions were 8.4 vs 2.6 The legend of his great-great-grandfather who was the first Librarian of Congress, the first acting mayor of Richmond, Virginia when that city was establishing its basic city government, the clerk of the Bill of Rights Convention, the confidant and close associate of Thomas Jefferson, James Madison and even George Washington himself, had a profound impact on young Stuart Beckley. He often spoke of his childhood and the plans he had made early in life. The army was to be the beneficiary of the traditions passed on to him. In 1954 at his retirement from the Army he took his residence at Arlington, Virginia. Here, he became the senior engineer for Melpar, Inc. On December 19, 1961 Stuart Alfred Beckley died of lateral sclerosis and was buried on December 22 in Arlington National Cemetery at Arlington, Virginia. General Alfred Beckley died on his birthday May 26, 1888 at the age of 86 years, and was buried in the family plot of Wildwood Cemetery which he had so generously given to the people of his adopted city, county, and state.

importance to his nationally leading coal mining district. He voluntarily retired from Congress with the end of World War II in 1945 to return to business in Beckley. An active and important figure in West Virginia politics during this period, after retiring from Congress he became Chairman of the State Democratic Committee.

He first became interested in banking as a member of the Board of Directors of the Bank of Raleigh, Beckley. In 1912, he became Vice President of the Bank of Winding Gulf, which, in turn, on July 24, 1914, was chartered as the Beckley National Bank. Shortly after the formation of the Beckley National, he became President and served as its chief executive officer for 46 years. During his tenure as President, he saw the Beckley National Bank grow from a one room banking house to occupy a million dollar bank building of its own and become one of southern West Virginia's leading financial institutions. He was a charter member of the West Virginia Bankers Association "50 Year Club".

While still retaining a small tinancial interest in the newspapers published in Beckley, he actively engaged in other businesses. He was a member of the Board of Directors and at one time President of the Home Insurance Agency which had been organized in 1898. He was on the Board of Directors of Radio Station WJLS, named for him, and still interested in the printing and publishing industry through a financial interest in Biggs-Johnston-Withrow, a Beckley printing plant. Actively in real estate, he was President and majority owner of the First Beckley Corporation, owners and operators of the Beckley Hotel and other business properties and the President of the South Beckley Land Company, a real estate development firm.

Although a member of the Raleigh County Draft Board during World War I, Joe L. Smith was a part of that generation of Americans who did not see active military service because they were born either too early or too late. Nevertheless, he was active in a civilian or official capacity during both Wars and refused to consider retiring from Congress while there was any doubt concerning the outcome of the second World War.


A quiet and unassuming man, because of his newspapering experience he preferred to write his public statements rather than deliver them orally. During his long stay in Congress, he never addressed the House. His political oratory was confined to brief acknowledgements from the platform. He preferred to do his campaigning by personal correspondence conversations. His volume of mail during his terms of Congress was high and each letter personally was answered. His uninterrupted return by an ever increasing majority of the voters to the House of Representatives for a total of eight terms, one of the longest periods spent in Congress by any West Virginian, evidence the closeness he was able to effect with his constituency and to the effectiveness of his methods. His multitude of friends reelected him.

Personally financially successful, he was generous in his philanthropies. He could be counted upon to be among the leaders contributing to any worthwhile cause. After his death, his personal files revealed hundreds of scribbled promissory notes, spanning his adult lifetime, for "loans" made to many of his less fortunate friends. Even his closest associates were unaware of this phase of his generosity. It was his way of partially repaying the community for the opportunities it had offered him and the successes he had enjoyed.

He was an officer and trustee of the Beckley Presbyterian Church: a member of Beckley Lodge No. 95, A. F. & A. M.; a life member of the BPOE and a member of the LOOM. He belonged to the National Press Club of Washington, D. C., and the Black Knight Country Club. In the field of education, he was a trustee of Beckley College, Beckley.

Joe L. Smith was married on September 9, 1914, to Marian Christine Carlson, in Annapolis, Maryland, the daughter of Lawrence P. Carlson, of that city. He had two sons: Joseph Luther, Jr., and Hulett Carlson. He died in Beckley on August 23, 1962, (See INDEX)




Perhaps the story of these three brothers could fill a book the size of the one you're now reading, depicting a long gone era which would in itself embrace a comprehensive history of not only the Bair Brothers, but of Beckley and Raleigh County combined. For instance, Mr. Bair's first year selling automobiles produced only three sales, one of which was to himself. Mr. Bair claims that the first car he bought cost \$780. Since then his corporation sold as many as 500 cars a year.

"You can do anything if you are willing to work" he always maintained. "It doesn't take brains; it takes sacrifice. You have to give up a lot of things—be thrifty."

These seem like simple words with a simple philosophy, but they are still profound, far-reaching, and worthy of any man's attachment

Mr. McCreery removed to Hinton, Summers County, West Virginia in 1894, and continued his coal association as President of the Piney Coking Coal Land Co., and founded the McCreery Central Pocahontas Coal Land Co. and the James T. McCreery Co. He also became President of The National Bank of Summers of Hinton, built the McCreery Hotel, and engaged in many and sundry business occupations, until his death on May 18, 1925 at Bellepoint in Hinton. 

BECKLEY'S EARLIEST HISTORY—(Continued from page 941) "p. 34, 'The local happenings at this time (September, 1788) are of interest. John Beckley was elected mayor and Robert Pollard recorder.'"

A bit of the little-known romance in General Alfred's life as told by Mrs. Wanda Campbell Bledsoe, a close family relation: "Emily Neville Craig daughter of Major Neville B. Craig of Pittsburgh, Pennsylvania, was the first wife of General Alfred Beckley. She was visiting friends in Philadelphia when the general saw her on the street and instantly fell in love with her. Shortly afterwards he maneuvered an introduction, followed her back to Pittsburgh and they were married in a bare few months. General Beckley brought this city-bred girl to this wild and lonely wilderness. There were only two houses between Beckley and Vandalia, (now Fayetteville, West Virginia). "The wolves came right up to their doorstep and howled. And once when someone in the Hull family, who lived at what is now known as Raleigh, became ill, and sent one of their slaves to Mrs. Beckley, for help, she sent the slave back home, and started to go to them as soon as she could. When she was about half way there she met a bear in the road. Petrified with fright, she stood perfectly still. The bear came up close and sniffed at her garments, then trotted off into the forest. "Emily Craig Beckley died in Vandalia on March 9, 1845 at the age of 28 years. Her parents at Pittsburghy were notified, but it took them two weeks to get here. During that time the body was kept unburied. The trip from Pittsburgh was made to Point Pleasant by steamboat; from Point Pleasant to Charleston by stage, and it

isn't known how they completed the journey, unless it was made by horseback or wagon."

Stuart Heber Beckley was a surveyor. He died of pneumonia, a highly-fatal illness of his time.

Ella Lillie Knopp, who first married (Sheriff) William Robert Campbell, was born in Sewell, Fayette County, on December 31st, the last day of the year in which West Virginia was born.

William Robert Campbell died while serving as Sheriff of Raleigh County, he too, was born in the year of the birth of his newly formed state.

"Wildwood" the homeplace of General Alfred Beckley, was actually almost a town in itself. The homeplace, the cemetery and the locality were known under this name.

John Price Beckley was killed, with his friend William E. George, by lightning at what used to be called the Preston home on South Heber Street, during a storm when the building was being constructed. He was an architect, practicing the profession at the moment of such an untimely death in 1900.

Margaret J. Price, the wife of John Beckley (son of Alfred Beckley-note: there are FIVE John Beckleys on the chart, alone), came from Greenbrier county. His wife, Jesse M. Kay, was the daughter of James and Julia Kay.

William G. Beckley, as did Isaac C. Beckley, his next youngest brother, moved to Auxvasse, Mo., where they also established permanent homes, and stayed. From these two brothers, several hundred offspring now exist. ROBERT WRISTON (M.D.) (Continued from page 980)







GROVER CLEVELAND HEDRICK (Sept. 23, 1881-Apr. 25, 1960; see earlier detailed biography, page 208). At the age of seventeen years Mr. Hedrick began his business career with a first grade teacher's certificate. After three years teaching in the Raleigh County Schools he attended Marshall College (now University), where he worked his way through graduation. Establishing his home in Mabscott where he was employed at the C & O depot as a freight hustler, later going into the Milling and Mercantile business. After his first child was born he moved his small family to Beckley, entering the banking business, the work he was to follow the rest of his life as described more thoroughly on page 208 of this trilogy. Mr. Hedrick's great strength both physical and mental served him and this community exceedingly well. A widely accepted authority throughout the banking world, he was a natural organizer, financial advisor, and civic leader, probably not paralleled in his time. Indefatigable and with a born instinct for questions of finance, he had a bent in these capacities for drawing friends and business associates into whatever project he put his hand to organizing. In addition to his long and strenuous hours he was ready and willing to serve any community project brought to him. He maintained an open-door philosophy which made him a man of considerable demands both at home and abroad. He served as a Federal Food Administrator for Raleigh County during the first year of World War I, and as chief executive officer of his banking institution until the moment of his retirement shortly before his death April 25, 1960. (See INDEX)

OPPIE L. HEDRICK, the oldest child of Grover Cleveland and Ethel Fink Hedrick, is a practicing attorney in Beckley. Born on June 14, 1907, he attended Beckley Institute, and the Beckley free schools. He completed his academic work at Marshall University, Huntington, W. Va., where he had served as treasurer of his freshman class. Here he was one of the founders of Phi Tau Alpha fraternity, which later became a chapter in the national fraternity of Sigma Alpha Epsilon. While attending Marshall, he and the former Alice Schweitzer of Huntington, West Virginia were married. Subsequently thereto, he was employed by the Amere Gas Utilities Corporation in the construction of a gas pipeline system in and about the City of Beckley, and later he was employed by the Gulf Refining Company of Pittsburgh, Pa., as a representative in West Virginia, Ohio, and Kentucky. Early in the 1930's he enrolled in George Washington University and later completed his law work in the law school, and subsequently became a member of the Bar of West Virginia in 1937. At George Washington, he was initiated as a member of Phi Alpha Delta. He is therefore a member of the American Bar Assn., West Virginia Bar Assn., West Virginia State Bar, Bar of the United States Supreme Court and the American Judicature Society, and various United States Circuit and District Courts. He is a member of the Elks and Black Knight Country Club. Earlier in his career, he served several terms as Police Judge of the City of Beckley. In 1949 when his father, Grover C. 



This particular John McCulloch was born in 1792 when George Washington was serving his first term as President. His wife was in her 77th year when she died. By the by, Mary E. McCulloch was the daughter of Andrew Bryan, great uncle of William Jennings Bryan.

Speaking of the several John McCullochs, the late Dr. John H. McCulloch, (Dec. 14, 1885—March 18, 1939) was one; and the current John H. McCulloch is the new young councilman of Beckley whose hobby is the collecting of Indian artifacts, son of the late Dr. John Howard McCulloch.

There was another John McCulloch, an uncle of Edward McCulloch, who died young. He was John McCulloch, brother of Charles E. McCulloch, Ed McCulloch's father. This particular John McCulloch died July 9, 1881, at the age of 37 years, 6 months and 22 days, according to figures on his grave marker. John McCulloch, (1792–June 12, 1884), great-grandfather of our new councilman—and Mrs. Hulett C. Smith and Albert M. Tieche—was sheriff of Mason County long before Virginia was rent in twain. When he had collected the taxes his was the job, as Ed McCulloch put it, "to carry the proceeds to Richmond." This Sheriff John McCulloch did.



He was an automobile, real estate, and live stock dealer. He has a brother, T. F. Whitlock, Fayetteville; two sisters, Mrs. Nettie Taylor, Martinsville, and Mrs. Mary Lucy Boyd, Fayetteville; four half brothers, Dewey Ashby, Fayetteville, Jessie Ashby, Chicago, Ill., and Joe and Monroe Ashby, both of Greensboro, N. C. On October 16, 1926 at Packs, West Virginia he married Icie McKinney, daughter of Abraham Garfield and Judy Edry Good McKinney. He has three sons and two daughters: Grady, Beckley, Billy, Summersville, and Jimmy, Mrs. Thelma Neal, Beckley and Mrs. Anna Frances Wilder, Huntington. Mr. Whitlock spent his boyhood days in Virginia, dealing in livestock; moved to Kingston at the age of 22 and worked for the Kingston Mining Co.; moved to Oak Hill where he worked as an automobile salesman for the Pat Hamilton Motor Company for four years; 1932 was awarded the Plymouth-DeSoto automobile franchise and formed the Oak Hill Trading Post Company which he owned and operated in Oak Hill until 1949, when he moved his automobile business to Fayetteville, forming the Whitlock Motor Company. Mr. Whitlock amassed a fortune in the automobile business and can lay claim to being the king of West Virginia's used car dealers. His office was located at the biggest Whitlock Co. lot, a mile south of Fayetteville on U. S. 21. When he opened his business, he traded some cars but it was mostly livestock, ponies, cows, horses and mules. He later expanded into real estate too. He had at least 30 houses or business places and five farms. He was a lover of horses and ponies. He

had ponies scattered in Fayette, Raleigh, Summers, and Kanawha Counties. Although scattered over these four counties, most of Mr. Whitlock's ponies were kept at his farm on U. S. 21 just north of Oak Hill. He purchased three-fourths interest in the Shumate Dairy Property on Harper Road. He sold and traded work horses, cattle and mine ponies for many years. He later discontinued raising anything but Shetland ponies. He bought two dairies near Fayetteville, the Bragg Dairy Farm and Maple Lane Farm. For a time he operated the Maple Lane Farm as a dairy but it later became stocked with ponies. He also had ponies on a rented farm near Belle in Kanawha County. The ponies were sold to the mines for working in the mines in West Virginia, Virginia, and Kentucky. After the machinery took over the ponies' jobs he discontinued to raise them to sell for working purposes. He started breeding them to a size no larger than a collie dog. These little ponies were in a great demand at this time, about 1960. The long-haired ponies graze in acres of rolling pasture land all year and spend very little time inside the barn. When the weather gets very cold, the ponies are friskier than ever. The animals were never taken to auction sales, but were sold at the farm. Most of the ponies were sold as children's pets. Mr. Whitlock had some of the smallest ponies anywhere. He had one pony that weighed only 15 pounds when it was two weeks old. When the pony was three years old, it was only 29 inches tall. It may have been the smallest pony in the world. Mr. Whitlock died at 3:15 a.m., January 4, 1960 in an Oak Hill hospital after an illness of three months. At the time of his death he owned over a thousand Shetland ponies; more than anyone in the United (See INDEX) States.


ROBERT WRISTON, (M.D.) "The career of Dr. Robert Wriston as a physician and surgeon began at Beckley in 1906. He is one of the very accomplished professional men of Raleigh County, and has been very active in all that concerns his profession and the general welfare and advancement of the community."

A native West Virginian from Fayette County, "his grandfather, Caleb Wriston, served as a Confederate soldier in the Civil War, and his maternal grandfather lost his life in that struggle. The Wristons were of Scotch ancestry, and the family has been in Virginia for a number of generations." His father, Mr. I. G. Wriston, and his wife lived in Nesco where he had been a farmer and for two terms held the office of justice of the peace, and was an active member of the Methodist Episcopal Church. Fresh from his medical training in Baltimore, where he was resident physician in the City Hospital, he began his work at Beckley. "Dr. Wriston handles a general medical and surgical practice, and every year or so he gets away from the routine of home duties to come into contact with the leading men and schools of the country. He took postgraduate work in the New York Polyclinic in 1908 and again in 1911, pursued special studies in Tulane University at New Orleans in 1917, and in 1921 and 1922 pursued courses in the Augustana Hospital and under Dr. Printy at Chicago.



Also, this seemed to be the same case with the two families, mentioned above, who went east, to Virginia. Today, the western groups reside in Washington, D. C., St. Louis, Mo., Kansas City, Columbia, Salisbury, and Mexico, Mo.

One of the most interested of the Beckley clan in genealogy—of the so-called Missouri group—is Mrs. L. E. (Marie Martin) Clark, Mexico, Mo., who has contributed enormously to the present compilation. (Also Fulton, Mo.) Granddaughter of Wm. G. Beckley.

The name Jatho (see Chart) is pronounced <u>Yato</u>. Several of these children have migrated to Florida and Illinois.

Intensely interesting is the picture taken only a short while ago (to be seen among the Beckley Photographs), of Miss Gussie (83) and John Beckley (85), only living children of the late William G. Beckley. They live in Mexico, Mo.

Also not to be overlooked is the likenesses of TWO remaining John Beckleys: the elder, mentioned in paragraph above, and his 14-year old grandson, Johnny.

At the moment word has not been received from the Isaac Beckley, the Walter Beckley, and the Mrs. Neville Beckley Satterfield descendants or families.

Stuart Alfred Beckley, the grandson of Alfred Beckley, Jr., is a retired colonel in the U.S.A.; lives at Arlington, and is senior engineer for Melpar, Inc., in electronic research and development. (See Frontis piece & INDEX)

Henry Martin Beckley died at 32, in Baltimore. He was owner of a store in Fincastle, Va., and had gone to the Maryland market to replentish his stock of Merchandise. It was reported that he had lost the money to be used for that purpose.

Dictated by Hal M. Scott.

From the original Minute Book of the City of Beckley, we find the following:

"Raleigh County, July 15, 1872. Pursuant to an Act of the Legislature of West Virginia, passed on the 20th day of February, 1872, incorporating the Town of Beckley, a majority of the qualified voters residing within the boundary being present. Proceeding to the election of officials, John Beckley was elected Mayor of the City; John W. McCreery, Recorder; Edwin Prince, Joseph Hanna, James T. McCreery, Dr. William M. Overton, and M. A. Ellison, Councilmen; and the said Mayor, Recorder and Councilmen qualified by taking the oaths of office required by law, whereupon the Council appointed E. D. George Town Sergeant, Martin Ellison Assessor, and George Stovall Superintendent of Roads,

Streets and Alleys, who qualified by taking the oaths of office required by law. And the Sergeant, together with John W. McCreery, his surety, entered into & accepted a bond in the penalty of One Thousand Dollars, payable to the Town of Beckley & conditions according to law. On motion the Council adjourned to meet at the call of the Mayor. /S/ John Beckley, Mayor, and John W. McCreery, Recorder."

At the meeting of the Council of the City of Beckley, January, 1873:

"If any country hogs, horses, mules and sheep shall come within the corporation, to the annoyance and disturbance of the citizens therein, the sergeant shall give the owners, or owner, of such stock ten days notice that he, or they must take them out of said corporation and keep said stock out and if said owner, or owners, shall fail to remove them within three days then the sergeant shall take charge of such stock and, after giving five days public notice shall sell the same at public auction for cash." "On motion it is ordered that no wood pile shall occupy more than eight feet of the street from the fence out.

All persons are required to use due diligence to keep their dogs from going to church, and if any person permits his dog to follow him to church, & he knowing of the same, he shall be fined not exceeding One Dollar for each offense. . . . "

At the January 8, 1879, meeting of the Council of the City of Beckley:

"If any person unlawfully shoot at another person in any street in the Town of Beckley, or in any place of public resort therein, he shall be confined in jail not exceeding thirty days and fined not exceeding Twenty Dollars for such offense."

From the January 9, 1884, meeting of the Council of the City of Beckley:


"The Council of the Town of Beckley having carefully and impartially examined the returns of the election held on the 3rd day of June, 1884, do hereby certify that in the said Town of Beckley for the office of Mayor, John Beckley received 12 votes and George W. Cook received 1 vote. For office of Recorder, John W. McCreery received 13 votes. For the office of Councilmen, Joseph Hanna received 13 votes, J. Q. Stovall received 13 votes, G. W. Cook received 12 votes, W. H. McCreery received 13 votes, John Prince received 13 votes E. D. George received 1 vote. . ."

As evidence that the Town was growing, we find in the Minutes of January 7, 1891, of the Council of the City of Beckley, the following:

"The Council of the Town of Beckley having carefully and impartially examined the returns of the election held in the said Town on the 5th day of January, 1891, do hereby certify that in said Town for the office of Mayor T. K. Scott received 26 votes; for Recorder John F. Jones received 22 votes and John W. McCreery received 5 votes. For Councilmen J. F. Harper received (Continued on page 986)

WE LIVE IN DEGENERATE DAYS PRINCE TOLD BECKLEY IN 1877

"We live in degenerate times," wrote Clarkson Prince

from his home on Beaver Creek to General Alfred Beckley at Wheeling in 1877.

Prince and General Beckley were kinsmen and close friends for many years. General Beckley had gone to Wheeling as a member of the House of Delegates from Raleigh County, the State Capitol then being located in the northern city. The original letter, in the possession of Mrs. A. C. Sutphin, of Beckley, who is a granddaughter of Mr. Prince, is as follows:

'Dear Cousin'

Dear Cousin Alfred,

Your very welcome letter of the 19th of January is at hand, received last evening. I will reply this the first opportunity; I am also truly pleased to learn that you have comfortable quarters. We have delightful winter at present, matters are getting on in our "diggins" much as usual. I am glad that you like your situation, I have no doubt that you will make an admirable member as I know you will be attentive to duties. The speaker gave you the right profession as Chairman of Military Affairs. "Pole" French will be in place as Segt. at Arms, remember me to him.

Shams

By your letter and also the papers, I see that all of the West Via delegation in Congress are at Wheeling, out on such reformers, however it is always thus with these modern shams. Jefferson views were that the Office should seek the man and not the man the Office, but we live in degenerate times.

Tell Henry S. Walker that I wish him God speed and would help him if I had a vote in preference to any of the delegation that should be in Washington. I trust that Faulkner may beat H. G. Davis. Now Gen. you know both men & I know that you will agree with me when I say that Faulkner is made of Clay and Davis of Mud. I trust your "cold" has departed and left you in good health. I calculate to go to Wildwood tomorrow to stay a day or two with Cousin Jane & Maria. I will take your letter with me to show them and will also write to you on Friday, giving you all the points I can gather, the mails have been very irregular for some time, but they no doubt will improve shortly.

Wheeling 'Clever'

Wheeling is a clever city, all whom have seen the Capitol speak of it in like terms as yourself, take good care of your health and don't be out much in the night air. All well this way. Susan & family desire to be remembered & send their love. You will write to me again soon please. It's great gratification to me to hear from you. I still keep telling that they must not look for this Legislature to do much as the Capitol question and the election of Senators must consume much time but more will be done than many preceeding Legislatures. You have done plenty for Raleigh Co. a long time ago now in my old age I would take it moderately and do as it seemed best without trouble or fuss, for should you do every thing that was asked, someone would trump up (Continued on page 988)






PEARL STOVER HARPER, daughter of the late Leonard Stover and Anna Laurie Watts Stover was born January 2, 1892 at Clear Creek, West Virginia. Mrs. Harper was educated in the public schools of West Virginia, Patti Stockdale Presbyterian School for Girls, the old Beckley Seminary, Beckley, West Virginia, and Marshall College, Huntington, West Virginia. She taught three terms of school before her marriage to French A. Harper, Sr. on February 2, 1910. They have three children. (See Mr. French A. Harper's biography on this same page.) Mrs. Harper operated the store at Harper for a time after her husband's death until her post office and other interests required her full attention. She was postmaster at Harper until her retirement in 1959. She was also a very successful business and real estate operator. She is an active member of the First Christian Church and is a member of the Kings' Daughters and Sons of that church. She lived at Harper at the time of her marriage. The home was located on the knoll in the center of about 17 acres. Several acres of this tract was heavily wooded with different varieties of evergreen trees. She called this homeplace "Green Acres". In 1957 Mrs. Harper purchased a home at 227 Woodlawn Avenue. Beckley, West Virginia where she now resides. (See INDEX)



FRENCH AUGUSTUS HARPER, SR. was born January 23, 1884 at Harper, West Virginia. He was the son of the late Henry H. Harper and Rose Ella Davis Harper. Mr. Harper was a graduate of Concord College, Athens, West Virginia and Roanoke Business College, Roanoke, Virginia. Mr. Harper married Pearl Stover on February 2. 1910, daughter of Leonard and Anna Laurie Watts of Clear Creek, West Virginia. There were three children born to this union. One son, French Augustus Harper, II of Beckley, West Virginia; two daughters, Anna Watts married to James M. Kay of New York City, New York; and Rose Ella married to Attorney, E. Carl Meadows of Beckley, West Virginia. Mr. Harper operated his late father's rather famous general store at Harper and the large land and coal holdings at Harper. He was a lifelong member of the Methodist Church and maintained that church which his father built on the knoll of Harper opposite their home. He was Sunday School Superintendent from the age of 18 years until the time of his death. He was also a Mason. Harper and Harper Road were named for this family. He was a great lover of animals and kept thoroughbred riding horses. His stables were unusual for that day. He had running water and electric lights and all the conveniences most people did not have at the time. His greatest interest was in the people of the community and his church. Mr. Harper was truly a great philanthropist. (See INDEX)

keeper at Prince. For the first several years he did all of the toll keeping alone, twenty-four hours a day! Later, when traffic got heavier he employed three helpers. JOHN WALLACE McCREERY (Continued from page 994) Dr. John Earl McCreery, his son, was born in Beckley, in December of 1882 and died in April of 1937. His other son, Lacy, died early many years before. Senator McCreery was a stalwart for prohibition and politics, and used both qualities in keeping liquor out of Raleigh County. On the subject of "demon rum" he drove a hard, demanding bargain for his support to anyone aspiring for a membership to the County Court, since it was this body which either did or did not license the sale of intoxicants. For many years he was able to keep Hickman Garrison head of the Court because they saw the "likker question" eyeto-eye. It was reported that time after time bags of gold-as much as twenty-five thousand dollars at a clip-was dumped into Hickman's desk, for "just your signature" on the right piece of paper. But it never happened-at least while this other stalwart held the helm.

The McCreery home, built in 1906, stood on the site now occupied by the Appalachian Electric Power Company offices. (See pictures of this magnificent mansion and other data through reference to the general INDEX.)


Raleigh County's 1st Draft Board

There is so much talk and notoriety concerning the drafting of soldiers for the U. S. Army today that some reference to the beginning of this system might be of interest: Selective conscription became effective July 20 while a small company of war department officials in Washington worked throughout the day and far into the night drawing from a large glass bowl 10,500 capsules containing the serial numbers and fixing the order of army service liability for nearly 10,000,000 young Americans-the flower of the nation. (At the end of the above story published in 1917 there was a list by name and number of the first seven hundred drawn for this-the nations' first draft.)

The Raleigh County draft and exemption board, was composed of T. K. Scott, Joe L. Smith, sheriff, W. L. Foster, county clerk, Jackson Smith, and county health officer, Dr. D. W. Snuffer, is shown herewith. Aubrey O. Smith was the clerk.

In a "fifty years ago-1917" column of the Raleigh Register this notice was posted: "The Raleigh County draft and exemption board has completed the work of comparing and numbering the 4,358 registration cards made up in the forty-seven precincts of the county on June 5. Beginning with number one the entire list of cards was numbered consecutively." (See INDEX)


RALEIGH COUNTY'S 1ST DRAFT BOARD

1917 SELECTIVE DRAFT ACT (Continued from page 946) Legal Advisory Board: W. H. McGinnis, Chairman, Hugh A. Dunn and J. Lewis Bumgardner, Members. Government Appeal Agent, John H. Hatcher, American Red Cross Chairman: C. L. Beckner. Councils of Defense were established on October 1, 1917, and served continuously, members thereof having been recommended by the County Draft Board as required by law and representing the various magisterial districts as follows: G. C. Hedrick and Frank M. Foote, Town District; P. C. Lynch, Shady Spring; Owen McCarthy, Richmond; M. E. Kent, Trap Hill; John W. Wilson, Slab Fork; E. C. Colcord, Jr., Marsh Fork; C. E. Sandberg, Clear

State-wise, on September 26, 1917, Major George S. Wallace was transferred to Washington and was succeeded by his assistant Capt. Breckenridge Jones as Chief of Department of Military Census and Enrollment and served until June 7, 1918 when he was succeeded by Capt. Fleming N. Alderson of Richwood.

There were two District Boards, Northern and Southern, two boards known as Industrial Advisors, Northern and Southern, eleven Medical Advisory Boards each normally composed of six members including a dentist. There were also a Central Legal Advisory Board composed of four members with each county having a Legal Advisory Board composed of three members. There were 65 local boards operating in the state each with a Government Appeal Agent. Order of selection was by lottery, the drawing having been made in Washington and a master list containing the numbers as drawn certified to each local board.
